- 2002 Sub-Investigator-A multicenter, randomized, double-blind, double-dummy, active-comparator (controlled released oxycodone), placebo-controlled parallel-group trial assessing the analgesic effect of COX189 in the treatment of postsurgical pain following total knee or hip arthroplasty
- 2002 Sub-Investigator-A randomized, double-blind, placebo-controlled trial of the effect of Rofecoxib 50 mg and Hydrocodone 7.5 mg with Acetaminophen 750 mg in patients with postoperative arthroscopic pain
- 2002 Principal Investigator-Double-blind, randomized, dose-ranging, parallel-group comparison of the efficacy and safety of extended release Tramadol Hydrochloride (Tramadol HCl ER) 100 mg, 200 mg and 300 mg, Celecoxib 200 mg and Placebo in the treatment of osteoarthritis of the knee and/or hip
- 2002 Sub-Investigator-An international, multi-centered, stratified, randomized, double-blind, double-dummy, parallel-group, 52-week gastrointestinal clinical study to demonstrate that COX189 (400 mg qd) reduces the risk to develop complicated ulcers as compared to NSAIDS (Naproxen 500 mg bid and Ibuprofen 800 mg tid), in osteoarthritis patients
- 2003 Principal Investigator- A four-arm study comparing the analgesic efficacy and safety of Tramadol HCl once day 100, 200 and 300 mg versus Placebo for the treatment of pain due to osteoarthritis of the knee MDT3-003.
